MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN

THE MINISTRY OF LAND, TRANSPORT AND MARITIME AFFAIRS OF THE REPUBLIC OF KOREA AND THE ARAB CIVIL AVIATION COMMISSION

The Ministry of Land, Transport and Maritime Affairs (hereinafter referred to as MLTM) and the Arab Civil Aviation Commission (hereinafter referred to as ACAC);

MINDFUL of the importance and significant contribution of civil aviation to the socio-economic development of their Member States and the exchanges between the Republic of Korea and Member States of ACAC;

MINDFUL of the increasing volume of air traffic between the Republic of Korea and Member States of ACAC;

DESIROUS of developing meaningful co-operation bonds so as to promote the safe, efficient and sustainable development of civil aviation in the Republic of Korea and Member States of ACAC;

HAVE REACHED THE FOLLOWING UNDERSTANDING:

PARAGRAPH I INFORMATION AND CONSULTATION

MLTM and ACAC hereby decide to exchange any information relating to the development of civil aviation in the Republic of Korea and Member States of ACAC. Such an exchange of information will, however, be without prejudice to matters which may be considered as confidential by both Sides or of no interest to either Side.

PARAGRAPH II SCOPE OF CO-OPERATION

MLTM and ACAC will co-operate in all areas of international civil aviation, particularly in safety, security, environment and CNS/ATM fields, within their respective mandates including, but not limited to, the followings:

- 1. Exchange of information
- 2. International events and meetings
- 3. Assistance with financial resources
- 4. Training programs
- 5. Identification of joint projects



PARAGRAPH III METHODS OF CO-OPERATION

- 2. The Secretariats will establish and maintain consultations through:
- 1) Exchange of letters and documents
- 2) Reciprocal visits
- 3) Invitations to meetings
- 4) Consultations and co-ordination, when necessary

EXECUTIVE LEVEL

Senior representatives of each Side will attend meetings of the other Side on a reciprocal basis. Consultation and co-ordination meetings will be organized prior to ICAO Assemblies and/or major international civil aviation events/meetings. MLTM will inform ACAC of any particular relationship it has established with Member States of ACAC and vice-versa.

IMPLEMENTATION ARRANGEMENT

In support of this Memorandum, specific projects and implementation of arrangements for the projects will be set out in a form of Annexes to this MOU. When signed by the Sides, such Annexes will become part of this MOU.

PARAGRAPH IV GENERAL PROVISIONS

This MOU is not intended to create any legal obligations under international law.

Each Side will bear its own costs incurred when implementing the provisions of present agreement unless otherwise jointly decided. All the activities under this MOU will be subject to the availability of appropriate funds and personnel of each Side.

PARAGRAPH V CHANNELS OF COMMUNICATION

Communications between MLTM and ACAC for all matters relating to this MOU will be channeled through their respective Secretariats.

PARAGRAPH VI REPRESENTATION

MLTM and ACAC will meet every three years to review the progress of activities jointly carried out. Such meetings will be held either at MLTM headquarters, Gwacheon-city, Republic of Korea or at ACAC headquarters, Rabat, Morocco, on a rotation basis, or in another jointly decided location.

PARAGRAPH VII DURATION

This MOU is for an indefinite period. Either Side will, however, have the right to terminate it by giving six months' advance written notice to the other Side. In the event of termination by one of the Sides, necessary steps will be taken by the two Organizations to ensure that such termination is not detrimental to on-going projects implemented within the framework of this MOU.

PARAGRAPH VIII AMENDMENTS

MLTM and ACAC may, in implementing this MOU, take supplementary measures compatible with the provisions of this Memorandum. This MOU may be amended or modified, as the case may be, by mutual consent of the Sides hereto. Each Side will give full and sympathetic consideration to any proposal put forward by the other Side under this paragraph. Any such amendment or modification will be made in writing and duly signed by both Sides.

PARAGRAPH IX RESOLUTION OF DISAGREEMENTS

Any disagreement regarding the interpretation or application of this MOU will be resolved between the two Sides and will not be referred to a third party or tribunal for settlement.

PARAGRAPH X COMING INTO EFFECT

This MOU will come into on the date of signature.
